

Defining "Full-Time" Tuition and Fees at Public Flagship Universities and Community Colleges

Several national reports each year calculate national average tuition and fees. According to the College Board's <u>Trends in College Pricing</u>, the best known of these, the average full-time tuition and fees at a public four-year university in the U.S. was \$8,893 in 2013-14. At public two-year colleges, it was \$3,264. Other often-cited reports with slightly different national average calculations include the National Center for Education Statistics (NCES) <u>"First Look" report on student charges</u>, and the Washington State Achievement Council's <u>National Tuition and Fees Report</u>.


But "full-time" for tuition purposes doesn't always mean the same thing. In the College Board's survey, it means the cost of 30 semester credits per year. To get a bachelor's degree, a student would normally pay those fees for four years. For NCES, however, the minimum is 24 credits per year, depending on what an institution determines is typical for its students. At many community colleges and open-access four-year institutions, for example, 12 hours is a "full-time" course load, and institutions report accordingly. In those cases, students would have to pay the "full-time" rate for five years to complete a bachelor's degree. So even institutions that have comparable published "full-time" rates in IPEDS could be quite different in terms of the total sticker price of a college degree.

There are no published data nationally on the structure of tuition and fee charges, so we researched websites of 50 public flagship universities and 50 randomly selected community colleges—one from each sector in each state—to get a sense of how charges for "full-time" might vary from one institution to another. Tuition structure can also provide incentives or disincentives for "full-time" students to take 15 hours, the normal course load to complete a degree on time.

Since a few institutions vary their charges by student class level or discipline, we decided to search for what an in-state freshman majoring in liberal arts would pay taking 12 compared to 15 credits per term. Here's what we found:

1) At most (35 out of 50) public flagship universities, "full-time" students pay a fixed rate, so there is no additional out-of-pocket cost to enroll in 15 hours instead of 12.

- Variously called "block," "flat," or "plateau" tuition, this provides the generally middle-income student bodies at these institutions with a strong incentive to enroll in as many courses as they can manage.
- 2) At most (42 out of 50) community colleges, on the other hand, tuition is charged per credit, so students taking 15 hours pay more out of pocket than those who take 12. This creates a disincentive for the generally lower-income students at these institutions to take more than the 12 hours they need to be eligible for maximum federal and state financial aid awards.
- 3) At 6 out of the 15 flagships and 7 out of the 32 community colleges that charged more for 15 hours than for 12, the additional tuition and fees were "discounted". These institutions typically had one set of required fees based on per-semester attendance and another set based on per-credit enrollment. At these institutions, there is an incentive for students who can afford it to take more courses at the "discounted rate." There is usually no financial aid available for the additional fees, however, so low-income students may be less apt to take care of the "sale."
- 4) This information was very difficult to find. A native English-speaking research analyst with a graduate degree often struggled to find and interpret basic tuition and fee information.
- 5) Institutions have highly variable definitions of "tuition" and "required fees". Some have an all-in-one price, while others have a catalog of itemized fees that rival a typical cell phone bill. The major national surveys mentioned above all have fairly consistent definitions that standardize these into one "tuition and fees" number, but institutions' own sites often follow their own bureaucratic and confusing logic.



Comment: Changing Tuition Structure as a Tuition Increase

Institutions sometimes change their tuition structure as a revenue-raising tool. Those with "flat" tuition will say—justifiably—that they are getting no revenue for some of their courses and move to linear tuition, which is the equivalent of imposing a 25% tuition increase only on the students who are actually on-track to graduation. Those with linear tuition will lobby move to a flat rate as an incentive for students to take more courses—again, justifiably so. They will typically set the new rate at the level formerly charged for 15 hours. In either case, institutions can claim not to have raised tuition by altering the definition of "full-time". In the first case, tuition did not go up for students taking 12 hours. In the second case, it did not go up for students taking 15.

In paying attention only to the annual rates of increase in "full-time" tuition, it is easy to miss the importance of tuition structure and the potential impact on students incentives and ability to complete their degrees on time. Governing boards and education reporters should recognize that changing tuition structure is a tuition increase for some students, but not for others.

While tuition increases are sometimes required, it is important to recognize the strategic value of tuition structure. If a tuition increase is necessary, then moving from linear to flat tuition can be a way to reduce barriers to completion, especially in the vast majority of states that do not provide additional financial aid to students who take more than 12 credits. Pell Grants are no help here either. But when institutions move the other way, from flat to linear tuition, they create new financial barriers to on-time degree completion.
